

RGC MINUTES – March 13, 2006  
MEETING CALLED TO ORDER  
AT 7:00 PM BY Joe Santone

Absent: Bryan Lange, Boyd Robertson, Chuck Heath, Paul Christensen, Doug Graf  
Minutes from February Meeting were approved.

**SPECIAL GUEST:** Jeff Couwenhoven, our new Golf Course Superintendant – Said he is working on the bunkers to remove rocks and other loose impediments. Then he spoke to us regarding the Audubon International Program which involves our club with the course. Further information and details later. We also specified an area for the planting of Skip Orr's tree. This will be located near the #10 tee and to the right of the 18<sup>th</sup> green. He also said they will improve their efforts to keep areas clean around the irrigation sprinklers that have yardage markers to make them more easily visible by players.

**PRESIDENT'S REPORT** – David Oxley, Jr. Memorial entries will be coming in starting April 1 with a deadline of May 22. These dates were established by the JGANC. The tournament date is June 12 and I am looking for as many volunteers as possible.

**VICE PRESIDENT'S REPORT** – The Christmas fund is approximately \$900.

**SECRETARY'S REPORT** – Latest numbers show we have 418 active members.

**TREASURER'S REPORT** – No report available; new budget was presented to the board. After the budget, the board approved a motion to pay for the entry fees for the NCGA four ball event. Two teams from the regular flight and two teams from the senior flight provided each division has a minimum of 10 teams entered; it was also noted that the prize fund for away tournaments will be increased commensurate with the number of players.

**TOURNAMENT DIRECTOR'S REPORT** – Bryan informed the board that two teams in the 54 hole Team tournament had been disqualified for playing the improper format. He asked that we refund the entry fees to Jessie Sierra and Robert Acrea and this was approved by the board. The balance in the tournament fund is \$2,153.00.

**WEBMASTER** – The web is going well and we are still working on establishing a 2<sup>nd</sup> Pay Pal and tournament handicap information.

**HANDICAP CHAIRMAN** – Excellent feedback from membership regarding e-mail and posting of tournament handicaps.

**RULES CHAIRPERSON** – Replacement of missing hazardous stakes on hole #6 (the Canyon hole) will be completed by the golf course superintendent.

**NEW BUSINESS** – We are establishing a senior flight to be eligible for this flight members must be 55 years of age. We must have a minimum of 12 players in this flight per event to establish a prize fund. This flight will tee off from the white tees during regular RGC events, but must play from the blue tees on all NCGA events. This has been confirmed with/NCGA based on yardage and slope.

**ADJOURNMENT:** Meeting was adjourned at 8:07 p.m. Next meeting April 13 at Diamond Oaks Legends and Heros at 6:00 P.M. This is prior to the open meeting on the same night.
