**Tournament Director's Report-** Steve Hendrickson reported Joe Santone is helping to run the Turkey Shoot.

**Handicap Chairman-** Gary is concerned that two RGC members have been identified as not posting scores from public play. Board members have seen these two playing golf at Diamond Oaks and those scores were not recorded by GHIN. A letter will be going out to these members stating that if they do not begin posting their non-tournament rounds that they will be suspended from the club." Also, half of the field in the last Diamond tournament did not post scores.

New **Business-** A rules question came up at the last tournament about the retaining wall left of hole #5, and the property owners iron fence next to the retaining wall. A ball came to rest on the wall. Is the wall, or fence the out of bounds boundary? It was decided at the meeting the retaining wall is out of bounds. Freida made a motion to amend our local rules to include retaining walls as out of bounds.

The NCGA is going to issue new plastic membership cards with a listing of benefits on the cards for 2009.

Vice-President Rick Rusk to secure starting times for the board of directors golf outing Friday December 5,2008. This is the existing board, and incoming board members.

Scott Prenez approached Ken Lyon about opening the 2009 Diamond tournaments to non-diamond members in hopes of increasing the field, and prize money.
