Re write : One of the other things the tournament committee has been working on is a Player of the Year (Net and Gross). Here are the details to the how the standing will be calculated.

RGC will be keeping track of all individual stroke play tournaments (Home and Away) that count as play dates and towards a tournament handicap along with the Club Championship Match Play tournament.

RGC will provide a trophy to the Gross and a Net P.O.Y., based on the point accumulated throughout the year.

The points will be given to the top 5 Gross and Net players at each of the individual stroke play events.

Gross/Net(each flight) 1st Place - 10 2nd Place - 8 3rd Place - 6 4th Place - 4 5th Place - 2

The point values are double for the RGC Major Events.

1st Place - 20 2nd Place - 16 3rd Place - 12 4th Place - 8 5th Place - 4

Over All Field winners will also get an additional 5 points.

The standings will be updated as results are released. The standing are posted on the web page.

Hi everyone, the 2014 membership year is closed as of August 31st. We finished the year with 323 active members. Membership for 2015 will start on October 1st. The renewal rate and new membership rate will remain the same for 2015 at \$80 for renewal before December 15th, and new and late renewal rate as \$95.

As of this writing, the Diamond level benefits and fees have not been finalized but are expected soon and will be updated on the membership form when it becomes available. As always, you can renew your regular

membership or sign up a new member and add the Diamond membership at a later date. If you purchase the Diamond upgrade through the pro shop, they can give you the member package at the time of payment. Most everything in that package is only good for dates in the 2015 calendar year.

If you know someone that has been waiting to join, now is a good time to sign up. If they join now, they can have the benefit of a 15 month membership as their membership would activate for the rest of 2014 and all of 2015. There is also a special membership available for new/returning members sponsored by a current member can join for the \$80 renewal rate if signed up by the day of the invitational. There are still several tournaments before the end of the year, and new members can get a jump on qualifying rounds for the major tournaments to be eligible to play and compete for those tournaments individually or as part of your team. Handicappers Report



I always include the ESC (Equitable Stroke Control) table in my reports and hopefully you are all using it and adjusting your scores before posting them.

A motion was made and passed at the last Open Meeting regarding the Tournament Handicaps. I have been a bit perplexed as to why our Tournament Handicap system includes Away events in the calculation of the handicap. The Tournament Handicap is **NOT** used in away events. I talked to many people on the board and in the club about this and the answer was, "It has always been done that way." I'm not a fan of that answer or that thinking and as your Handicapper, I want the Tournament handicap (which is **only** used at Diamond

Oaks stroke play events) to reflect the tournament scores that are recorded at Diamond Oaks. The motion was to only use Diamond Oaks stroke play tournament scores in the calculation of the Tournament handicaps.

The new Tournament Handicaps are posted on the website and I have gone in and removed all of the away scores from the list of scores used to determine the Tournament Handicaps. The new T Handicaps are a reflection of the scores posted in Diamond Oaks stroke play tournament events. I strongly believe that these new Tournament Handicaps will more closely reflect a player's abilities (and history) in Diamond Oaks events. We will continue to use your full GHIN index at the away events.

The golf year is streaking by and soon we will be able to water our lawns again without massive guilt and shame as the weather turns cooler and hopefully we begin to see some rain. There are plenty of opportunities to get out with your fellow club members and play golf in the late Summer and Fall events. The Eclectic results are rounding into shape and there are still three events left that will make up your final score for the year in this year long event.

As always, it has been a pleasure being your Handicapper this year. Working with Neil Thomas on the Tournaments is a true joy as he is always on point and gets me everything I need in a timely fashion. Ditto for Tim Bryan. Rules Chair Message

Our winter was dry, and the word drought has become a staple in everyone's vocabulary. September is here, and with the exception of a few random days of badly needed rain and a few days of 100 plus temps, we have been fortunate to have had seasonally pleasant weather this summer. One would think that, under the circumstances, the term Abnormal Ground Conditions -- Casual Water or Ground Under Repair, with regard to wet areas, would not be in our golf vocabulary.

While many of us are seeing our beloved lawns turn dry and brown, our

beautiful Diamond Oaks facility uses reclaimed water to irrigate and keep our course green. Unfortunately, their more than normal use of water to achieve that goal causes us as golfers to encounter areas that are damp and soft or very wet and muddy. Thus, there are questions: Is it or is it not an "Abnormal Ground Condition" -- "Casual Water" or "GUR"; do I get relief and how do I take it?

Casual water is any temporary accumulation of water on the course that is not in a water hazard and is visible before or after the player takes his stance.

GUR is any part of the course so marked by order of the Committee.

A ball is in Casual Water or GUR when it lies in or any part of it touches the Casual Water or GUR.

Rule 25-1b

Except when the ball is in a water hazard or a lateral water hazard, a player may take relief from interference by an abnormal ground condition as follows:

If the ball lies through the green, the player must lift the ball and drop it, without penalty, within one club-length of and not nearer the hole than the nearest point of relief.

Decisions:

25/1 - Is soft, mushy earth casual water?

No. Soft mushy earth is not casual water unless water is visible on the surface before or after the player takes his stance.

25/4 - In a wet area, casual water is not visible before or after the player takes his normal stance. However, by pressing down hard with one foot, the player causes water to appear around the sole of his shoe. Is the player entitled to relief under Rule 25-1b?

No. Water visible through undue effort with the feet is not casual water.

25/16 - Is a rut made by a tractor considered a hole made by a green keeper and thus ground under repair? If not, should the Committee declare such a rut to be ground under repair?

Such a rut is not a hole made by a green keeper. The Committee would be justified in

declaring a deep rut to be ground under repair, but not a shallow indentation made by green keeping equipment.


