<u>President's Report:</u> Spoke to Nick, DO Pro Shop about prizes for the Oxley Tournament, will have poker chi ball markers also. Robert Kvick finished audit, everything in good order. One suggestion is to bring in line with RGC Bylaws, Art. 5- Duties 1B for authorization of funds over \$100. Discussion to review and possibility change bylaws to bring in line with normal practices.
