A motion was made to remove the money paid to the Superbowl tournament from the General fund for that prize fund. Motion failed as money had already been paid to the pro shop and could not be recovered. The By-laws and Tournament rules are under study for revision and the committees will attempt to address these issues for future tournaments.
