HANDICAP CHAIRMAN'S MESSAGE



Handicappers Report

EQUITABLE STROKE CONTROL

I always include the ESC table in my reports in the hope that you are all using it and adjusting your scores before posting them.

The Peoria Scoring System

Sometimes a new member or a guest in the Invitational does not have an established handicap. The process for allowing them an opportunity to compete for prize money is called the Peoria System.

Without handicaps, we can only use gross scores to determine how golfers place. However, gross scores - the actual number of strokes taken - obviously, and hugely, favor better golfers. The Peoria System is a way to handicap the un-handicapped - to calculate a "handicap allowance" based on just-completed play in order to produce net scores for golfers participating.

How the Peoria System Works

The Peoria System, in some ways, based on luck - allows a "handicap allowance" to be determined and then applied to each golfer's score.

Before tournament play begins, the tournament committee secretly selects six holes. These are two par 3s, two par 4s and two par 5s, one of each type per nine (e.g., one par-3 on the front, the other on the back nine).

Groups of golfers tee off and complete their rounds, playing stroke play and scoring in the normal fashion with one exception: double par is the maximum (for example, eight is the maximum score on a par-4).

Following completion of play, the six Peoria holes are announced.

The computer takes the scores on the six Peoria holes and totals them up. That total is multiplied by 3; the golf course's par is subtracted from that total; then the resulting number is multiplied by 80 percent. That result is the golfer's "handicap allowance." The allowance is subtracted from the player's gross score and the result is the net Peoria System score.

That sounds complicated. However, it's really not once you fully grasp the steps. Do it once and it will be easy the second time. Here is an example:

1. Once the round is over, the tournament organizers announce the identities of the six secret holes.
2. The computer finds those six holes on the scorecard and tallies up the total strokes for those six holes. Let us say that total is 30.
3. So the computer multiplies 30 by 3, which is 90.
4. The golf course par is 72. So subtract that from 90, and Player A (or Team A) gets 18.
5. Now multiply 18 by 80-percent, which is 14 (round off).
6. And that tells us that 14 is Player/Team A's Peoria System handicap.
7. Let's say Player/Team A's gross score was 88, so subtract 14 from 88.
8. And that is Player/Team A's Peoria System net score: 88 minus 14, which is 74.

You just have to know the steps. Easy Peasy.

I am back out on the course after my rehabilitation from surgery so make sure to say Hi when you see me on the course.

We are on the home stretch of the 2017 season and I feel like it's been a pretty good year!! We have only had a few rulings that needed to be addressed.

I know the invitational is a fun tournament with a lot of interesting games. That being said on hole 12 there was a couple of things I would like to clear up. Hole 12 is to be played as a scramble format. After you roll the dice and figure out the club to play that hole with you and your partner pick the best tee shot and continue to play the hole from the best ball position using the club you teed off with until the ball is holed. There was also a discussion on hole 12 that a 2 IRON is also a hybrid. That is incorrect. A 2 IRON is an IRON not a hybrid. If you rolled the dice and got hybrid or wood of your choice that is the club you are supposed to use. NOT A 2 IRON!!
